2. Review Plant Issues/Deficiencies

Nick D.-Bobby and I had a conversation and he sent me his notes from the last visit in August. He mentioned that you had some problems with 1409 and 1453, thought they might be leaking. Anything new with that? Internal or External?

Mark M.-One of them we have a leak on and the other one we think the circuit board might be fried. On the cold box we have a leak there. The level controller on the DGA re-boiler is out of service and they are working that level manually.

Nick D.-Which number is that one? I mainly mentioned it to get them on the list. As you get them corrected then we will pull them off of the list. I just wanted to raise the issue that he reported them after speaking with you. As things get taken care of we will remove them from the active list.

There was a period of time when the residue control valve and whether you could adjust it. Is there anything new with the 2393 B valve?

Barry S.-It's still a little bit slow but it's better since we did do the adjustment on it.

Nick D.-Ok do you think we should call it works complete and move it out of there?
