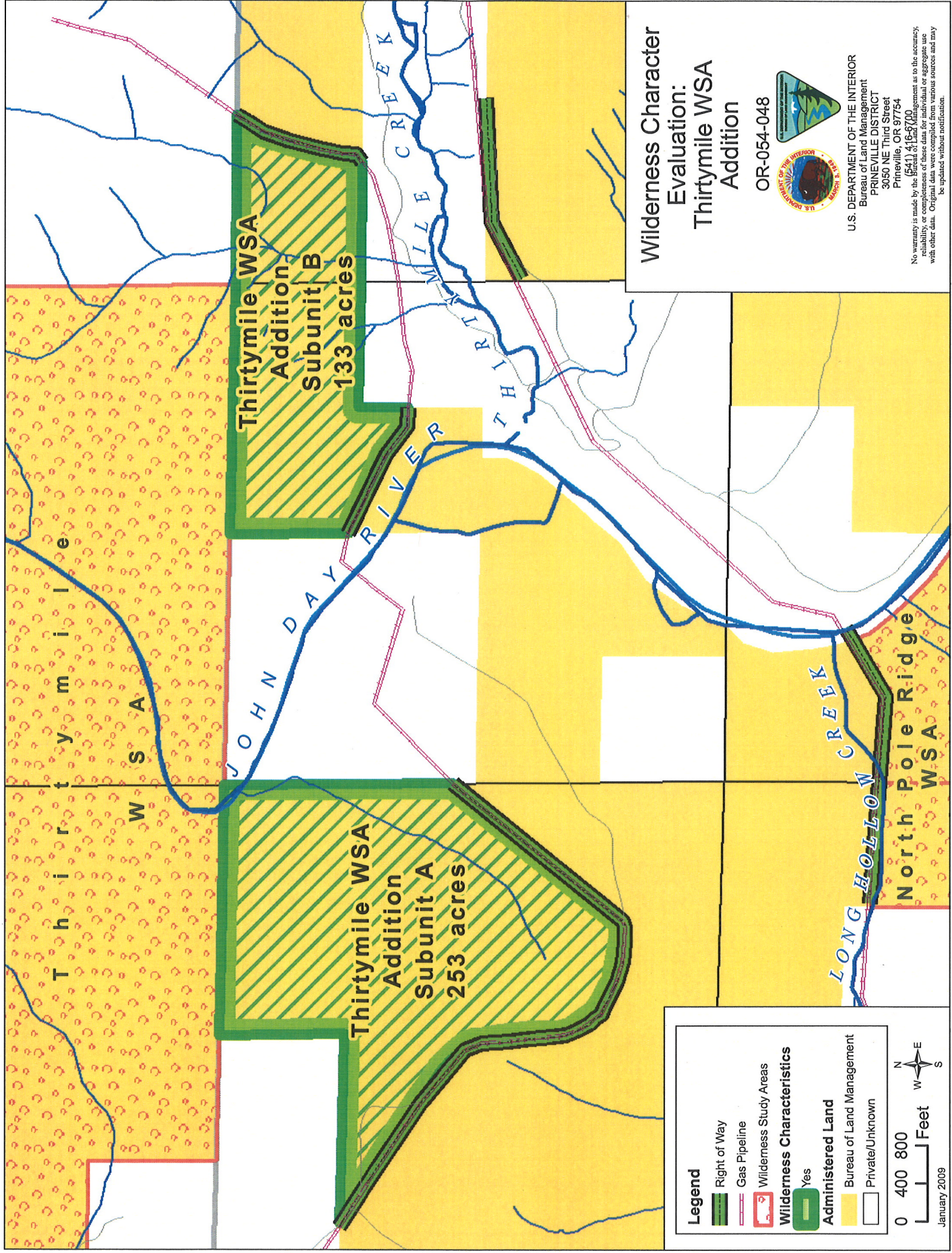

(1) Describe current conditions: (Include boundary features, land ownership, size, location, topography, vegetation features and summary of major human uses/activities).

**Location:** The lands are located in Sherman and Gilliam Counties, Oregon, approximately 15 to 18 miles west of the city of Condon. The inventory unit consists of two separate subunits which are adjacent to the Thirtymile Wilderness Study Area (WSA), one on the west side of the John Day River and one on the east side of the John Day Rvier.

### Original Inventory

The lands in the 2007 inventory include lands previously inventoried for their wilderness characteristics under Section 603 of FLPMA. In August 1979, the initial BLM OR/WA Wilderness Inventory effort addressed the lands in Subunits A and B, and in 1980, the Intensive Wilderness Inventory for the Thirtymile Unit (OR-05-001) addressed these lands in detail. The Final Intensive Inventory Decisions in November 1980 dropped 2,270 acres within the Thirtymile Inventory Unit from further study stating that for the lands north of Thirtymile Creek and east of the John Day River, "the opportunity for solitude or unconfined types of outdoor recreation is severely limited because of its size, configuration, and being nearly surrounded by private land". For the lands west of the John Day River and north of Pine Hollow Creek the report stated, "...the lands are in view of various improvement including roads." And "Opportunities for solitude or unconfined types of outdoor recreation are not outstanding, because of the very irregular shape of this area, and the very open nature of the topography encompassed within it." "In addition, there is no vegetative screening potential within both of the excluded portions of this unit."

### Description of Current Conditions

The 2007 subunits labeled as A and B is a portion of the lands that were dropped from further wilderness consideration in 1980 that are referred to above.

**Location of Subunits A and B:**

**Subunit A** (Pine Hollow) is located in Sherman County adjacent to the southwest corner of Thirtymile WSA. The subunit is bordered on the north side by the WSA and private land. It is bordered on the south side by a ROW for a Trans Canada Natural Gas Pipeline and by private land. It is bordered on the east side by continuation of the same pipeline ROW and on the west side by private land. The subunit is 253 acres in size.

**Subunit B** (Thirtymile Creek) is located in Gilliam County adjacent to the southeast corner of Thirtymile WSA. The subunit is bordered on the north side by the WSA and by private land, on the south side by a ROW for a Trans Canada Natural Gas Pipeline, and on the east and west sides by private land. The subunit is 133 acres in size.

**Location of Subunit A:** Portions or all public lands located in T. 5 S., R. 19 E., Sections 4 and 5.

**Location of Subunit B:** Portions or all public lands located in T. 5 S., R. 19 E., Section 6.

### Description:

The topography includes steep canyons and draws all draining eastwards into the John Day River. Slopes can be extreme. Only on the tops of the ridges and along the canyons are there any gently rolling or flat topography. Elevations range from 800 – 1000 feet in the river canyon bottomlands to over 2700 feet on the tops.

The vegetation on the steep slopes consists primarily of sagebrush and perennial grass (bluebunch wheatgrass, Idaho fescue), snakeweed, and introduced annual forbs and grasses. Western juniper is also present.

Describe:

The lands are grazed under two permits from BLM which are Allotment # 2629 for most of the unit, and a small portion in # 2518. Both of the land parcels found to possess wilderness characteristics are in Allotment # 2629. The range improvements are minor and are substantially unnoticeable.

The BLM staff found a minor vehicle route in T. 5 S. R 19 E., Section 6 which enters public lands from private land north of it and which dead-ends in a short distance. No Road/Way analysis was done it since it is unused and is naturally rehabilitating. BLM also identified the remnant of a short vehicle route in T. S., R. 19 E., section 5 starting at the pipeline and running east along the rim of an escarpment onto private lands. It is not being used and no Road/Way analysis was completed.
