

Spokane District Wilderness Characteristics Inventory

Summary of Findings:

Note: the totals provided below for number of acres found to contain wilderness characteristics are GIS-corrected and do reflect the final tally for acreages on file for Spokane District. They correspond with acreages as identified on the maps included on the website with each site's inventory report.

Unit Found to Contain Wilderness Characteristics within All or Part of the Unit:

- 1/28/13 Juniper Dunes OR-135-03: Two small sub-units Contiguous to BLM Wilderness qualified – the rest of the unit does not have wilderness characteristics. (Acres with Wilderness Characteristics = 1,039)
