

Awards Criteria and Nomination form for the Presidential Migratory Bird Federal Stewardship Award

Award Announcement and Criteria

The Council for the Conservation of Migratory Birds seeks nominations for the 2012 Presidential Migratory Bird Stewardship Award (Award). Nominations for the Award are due no later than January 16, 2012, to the U.S. Fish and Wildlife Service (FWS). Nominees can be a single Federal agency, a Federal agency and public or private partners, or multiple Federal agencies. **All nominations from the BLM offices must be submitted by January 10, 2012, to Geoff Walsh (WO-230) for submission to the FWS.** Nominations must be related to an action or project that has occurred in the last 10 years (i.e., initiated no earlier than January 2002).

Background:

Executive Order (EO) 13186 (*Responsibilities of Federal Agencies to Protect Migratory Birds*), signed in 2001, established that migratory birds are of great value to the United States and other countries. In recognition of that value, the Order directs Federal agencies to support the conservation intent of the migratory bird conventions by integrating, to the extent practicable, principles, measures, and practices into agency activities that benefit migratory bird resources. Presidential Migratory Bird Stewardship Award goals:

The Presidential Migratory Bird Stewardship Award will annually recognize a single project or action conducted by or in partnership with a Federal agency that meets the intent and spirit of the EO by focusing on migratory bird conservation. Actions may involve reducing existing or potential adverse impacts to migratory birds and their habitats, restoring or enhancing migratory bird habitat, and incorporating conservation of migratory birds and their habitat into agency plans, guidance, or other activities. The action should demonstrate leadership in inspiring others to further migratory bird conservation. This could include developing and implementing best management practices, a policy action, or research.

Nomination Procedure:

The BLM nomination will be submitted to Meghan.Sadlowski@fws.gov by WO-230. Because a Federal agency may submit only one nomination to the FWS, WO-230 will evaluate nominations to submit its best nomination for the award. Nominations submitted in previous years may be re-submitted for consideration. The FWS must receive nominations from Federal agencies by close of business day January 16, 2012. The award will be presented in May 2012.

Nomination Application

Goal of Award: Award acknowledges an action [see Award Announcement for definition] conducted by or in partnership with a Federal Agency that contributes to migratory bird conservation, meeting the intent and spirit of EO 13186. The Agency/action demonstrates a leadership role in inspiring others to take action in migratory bird conservation. This could include developing and implementing BMPs, a policy action, or research.

- 2. Co-applicant(s) if any; can be Federal or non-Federal entity. A co-applicant is a major contributor to the outcome of the project (e.g., without their contribution, the action would not have occurred):**

- 4. When was the action initiated? (Initiation date must be 2002 or later)**
- 5. Does the action take place locally, regionally, nationally or internationally? Please explain.**
- 6. How does the action meet or exceed agency mandates or daily activities?**
- 7. Explain how the action promotes or results in effective migratory bird conservation.**
- 8. Provide details that demonstrate how the action is innovative.**
- 9. Describe the roles and responsibilities of partners (if any). Partners are associated with the action through monetary or in-kind support.**
- 10. How might the action be transferrable to other sites managed by this or other federal agencies? Does the action contribute to a tangible need locally, regionally, nationally, or internationally? How is this being encouraged? Please explain.**
- 11. How does/did the action impact your agency's current migratory bird conservation practices?**
- 12. How does the action benefit migratory bird species of concern?**

All nominations must be submitted to Meghan_Sadlowski@fws.gov by a Federal agency. Federal agencies may submit only one nomination to the FWS. Each Federal agency should filter nominations within their agency to submit their best nomination. Nominations submitted in previous years may be re-submitted for consideration. The FWS must receive nominations from Federal agencies by close of business day January 16, 2012. The award will be presented in May 2012.
