## How to Provide Effective Comments:

The BLM is required to respond to comments that are in writing, substantive, and timely. The BLM is not required to respond to comments that are not substantive or to comments that are received after the close of the comment period.

## What is a substantive comment?

A substantive comment will...

- question, with reasonable basis, the accuracy of information in the EA.
- question, with reasonable basis, the adequacy of, methodology for, or assumptions used for the environmental analysis.
- present new information relevant to the analysis.
- present reasonable alternatives other than those analyzed in the EA.
- cause changes or revisions in one or more of the alternatives.

## What is a non-substantive comment?

A non-substantive comment includes:

- Comments in favor of or against the proposed action or alternatives without reasoning that meet the criteria of a substantive comment (such as “we disagree with Alternative A and believe the BLM should select Alternative B”).
- Comments that only agree or disagree with BLM policy or resource decisions without justification or supporting data that meet the criteria of a substantive comment (such as “more wood cutting should be permitted”).
- Comments that don’t pertain to the project area or the project.
- Comments that take the form of vague, open-ended questions.
