Agenda Item: Welcome and Opening Remarks

Presenters: Jennifer Jones, Deputy State Director, Communications and John F. Ruhs, Idaho State Director, BLM and Designated Federal Official (DFO) for the BLM Idaho Resource Advisory Council (RAC).

- Meeting called to order by Jennifer Jones at 9:02 a.m. Mountain Time
- John F. Ruhs welcomed everyone to the meeting and expressed appreciation and importance of RAC member participation in the first formal meeting of the BLM Idaho statewide RAC.

Presenter: John F. Ruhs, Idaho State Director, BLM

John F. Ruhs provided an overview of key Department of Interior (DOI) and BLM leadership, including Interior Secretary Deb Haaland; Laura Daniel-Davis, Principal Deputy Assistant Secretary, Land and Mineral Management; Nada Wolff Culver, Senior Advisor to the Secretary, Exercising the Delegated Authority as the BLM Director, and; Michael Nedd, Deputy Director of Operations.

Ruhs also highlighted DOI priorities:

- Identifying steps to accelerate responsible development of renewable energy on public lands and
- Strengthening the government-to-government relationship with sovereign Tribal nations.
- Making investments to support the Administration's goal of creating millions of family-supporting and union jobs.
- Working to conserve at least 30% each of our lands and water by 2030.
- Centering equity and environmental justice.

In addition, Ruhs discussed BLM operational adjustments in response to COVID-19 and provided an update on the status of revisions to national Livestock Grazing Regulations.

Agenda Item: 2021 Wildfire Season Outlook /Preparedness

Presenter: Dennis Strange, State Fire Management Officer, Idaho State Office

Dennis Strange provided an overview of the Great Basin Coordination Center Predictive Services Outlook from April through July, 2021. The outlook is showing normal potential for significant wildland fires for Idaho during that timeframe – however, the outlook is updated monthly and conditions can and often do change quickly and significantly. Strange also provided an overview of BLM Idaho's wildfire suppression assets (engines, dozers, aircraft, etc.), partnerships with cooperators, and operational adjustments in response to COVID-19.

Agenda Item: Great Basin Fuel Breaks and Fuels Reduction and Rangeland Restoration Programmatic Environmental Impact Statements

Presenter: Shannon Bassista, Project Lead, Idaho State Office

Shannon Bassista presented an overview of the Programmatic Environmental Impact Statements and explained that they are intended to help expedite fuel breaks and fuels reduction and rangeland restoration projects in Idaho and several other Great Basin States by providing analysis of common project elements. Local BLM offices can tier to this analysis to meet National Environmental Policy Act requirements for specific on-the-ground projects.

Agenda Item: BLM Idaho Recreation Site Management, Fees, and Associated Amenities Presenters: John F. Ruhs, Idaho State Director, BLM, DFO; Ken Crane, Burley Field Office; Jeremy Casterson, Field Manager, Upper Snake Field Office

John F. Ruhs provided an overview of the RAC's role and responsibility under the Federal Lands Recreation Enhancement Act (FLREA) to make recommendations to the DFO to approve, revise, or disapprove proposals to change fees at BLM recreation sites.

Ken Crane provided an overview of proposed fee changes as outlined in a business plan for the Lud Drexler Park and Milner Historic Recreation Area. The business plan includes a comparison of the costs of operating the sites, and the fee revenues currently generated at the sites, which results in a significant deficit. The business plan also includes a comparison of proposed fees with fees charged at similar recreation sites in the area and the results of the public comment solicitation process.

RAC Chair Robert (Bob) S. Unnasch asked for a motion from the RAC members on the proposed Lud Drexler Park and Milner Historic Recreation Area fee changes. Brenda Pace made a motion proposing that the RAC recommend approval to the BLM DFO of the Lud Drexler Park and Milner Historic Recreation Area Business Plans and proposed fee changes. Scott Nichols seconded the motion. The roll-call vote was unanimous in favor of the motion.

Jeremy Casterson, Field Manager for the Upper Snake Field Office, provided an overview of proposed fee changes as outlined in a business plan for the South Fork of the Snake River Recreation Fee Program. This program involves state and federal partners that manage ten developed sites. The business plan includes a comparison of the costs of operating the sites, and the fee revenues currently generated at the sites, which results in a significant deficit. The business plan also includes a comparison of proposed fees charged at similar recreation sites in the area and the results of the public comment solicitation process completed to date (additional public comments still need to be solicited to meet BLM requirements).

RAC Chair Robert (Bob) S. Unnasch asked for a motion from the RAC members on the proposed South Fork of the Snake River Recreation Fee Program fee changes. Bob Breckenridge made a motion proposing that the RAC recommend approval to the BLM DFO of the South Fork of the Snake River Recreation Fee Program Business Plan and proposed fee changes. Donna Bennett seconded the motion. The roll-call vote was unanimous in favor of the motion.
