Candela Renewables, LLC has applied for a right-of-way grant to provide the necessary land and access for the construction, operation and eventual decommissioning of a proposed 400 megawatt (MW) solar facility including battery storage facility and interconnection to the regional transmission system on Bureau of Land Management- (BLM)-managed public land, designated as a solar variance area.

Rough Hat Clark County Solar Project is proposed on approximately 2,400 acres of BLM-managed public land located in the Pahrump Valley in Clark County immediately adjacent to the county line, southeast of the Town of Pahrump and approximately 38 miles west of Las Vegas.

BLM is conducting virtual public information forums for the Rough Hat Clark County Solar Project. The information forums are being held as part of the solar variance application process and information gathered during the public input period will inform BLM's determination on whether to continue to process or to deny the Rough Hat Clark County Solar Project right-of-way application.
