National Recreation Trail gets TLC

BLM Central Coast Field office used revenue funds for Park Rangers to patrol and maintain recreation areas across Monterey, San Benito, and Fresno counties. ParkRangers collect fees, monitor campgrounds, provide outreach to visitors, and maintain the recreation sites. Our Recreation Park Rangers also team up with partners such as Americorps to do much-needed trail repairs and daily site maintenance.

Tumey Hills Clean-up and Route Maintenance

BLM Central Coast Field Office used the revenue to fund Park Rangers and lead volunteers to perform clean-up of left-over target shooter trash. Repairing fences, replacing signage, and graffiti removal are performed by Park Rangers at the San Joaquin Valley recreation sites as well.

Recreation Fee Dollars

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation Direct operating or capital costs associated with the recreation fee program



Other Accomplishments

In addition to the road and trail work performed at Tumey Hills and Coalinga Mineral Springs National Recreation Trail, the Central Coast Field Office has used revenues to support and lead volunteer groups in Clean-ups at San Joaquin Valley recreation areas.
