Visitor Center Gate



Gate installed at the visitor center

Recreation Fee dollars were used to purchase a gate for the visitor center to improve the Randall Henderson Trail access. The gate will provide safe access to the trail from the visitor center parking lot 24/7 while securing the visitor center and other facilities. The gate was installed in FY22.

Visitor Center Counter



Pneumatic vehicle counter and housing

Recreation Fee dollars were used to purchase a new pneumatic counter and associated equipment to track visitation to the visitor center. It replaced an older counter that had been utilized. Still, it was vandalized, and replacement parts were no longer available from the manufacturer.

Recreation Fee Dollars

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation. Direct operating or capital costs associated with the recreation fee program



Other Accomplishments

- Deep cleaning of the visitor center -Materials for roofing visitor center safety shed
- Supplies for visitor center maintenance and operation
