Please accept this letter as a formal expression of interest to nominate the following tracts of land located in Canadian County, OK for the April 2016 Oil and Gas Lease Competitive Bid Sale:

Lots 7, 8, 9 & 10 and the SW/4 SW/4

Lots 1, 2, 3, 4 & 5; S/2 S/2, and that part of Lots 10 & 11 described as beginning at a point 190 feet South and 340 feet East of the Northwest Corner of Section 26, thence South approximately 8°30' East 2,410 feet to the left bank of the North Fork of the Canadian River, thence Northwesterly along the left bank of said river a distance of 915 feet more or less to the West line of Section 26, thence North along said West line of Section 26 a distance of 1,040 feet more or less to the left bank of said river, thence Northwesterly along the left bank of said river approximately 875 feet more or less to the point of beginning including all accretions and riparian rights thereto

Lots 10 & 11 **less and except** the following tracts described as beginning at a point 190 feet South and 340 feet East of the Northwest Corner of Section 26, thence South approximately 8°30' East 2,410 feet to the left bank of the North Fork of the Canadian River, thence Northwesterly along the left bank of said river a distance of 915 feet more or less to the West line of Section 26, thence North along said West of Section 26 a distance of 1,040 feet more or less to the left bank of said river, thence Northwesterly along the left bank of said river approximately 875 feet more or less to the point of beginning **AND Less & Except** all that land lying East of a ditch beginning at a point 340 feet East and 190 feet South of the Northwest Corner of Section 26-13N-8W, thence North along the East bank of the Canadian River to section line, thence East along section line to quarter section line, thence South along quarter section line to South line of Northwest quarter of said section, thence West to East bank of North Canadian River, thence in a Northwesterly direction along said bank and East line of ditch a distance of 2,410 feet to the point of beginning including all accretions and riparian rights thereto
