Recreation Fee Program Spending & Accomplishment Highlights 2022

New Vault Toilets



Nampaweap Trailhead Vault Toilet

The Grand Canyon-Parashant National Monument installed new accessible vault toilets at Tassi Ranch, Grand Gulch Mine, and Nampaweap trailheads. These vault toilets will greatly reduce the amount of toilet paper and waste at these unique areas. \$76,106 in fee revenue from district-wide Special Recreation Permits was used to purchase and install the vault toilets and is recorded on the Arizona Strip Field Office's FY22 Expenditures table.

New Visitor Maps

The Grand Canyon-Parashant National Monument designed, purchased, and installed new visitor maps at various information kiosk locations throughout the Monument for \$3,000. The purpose was to enhance the visitor's recreation experience and protect resources. Interns from the Intergovernmental Internship Cooperative program at Southern Utah University helped by stabilizing and rehabilitating soils at the installation sites.

Recreation Fee Dollars

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating/capital costs associated with the recreation program

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.



Other Accomplishments

Rehabilitated trailhead parking areas by grading out ruts around the vault toilet areas and removing weeds.

Mended fencing along the forage preserve on September 24, 2022 for National Public Lands Day.

Rehabilitated a user created route around the gate at the north entrance of the Grand Wash Cliffs Wilderness Area.

Interns from Southern Utah University helped stabilize soils at the vault toilet installation sites.

The Recreation Aviation Foundation contributed volunteer hours to assist with installation of the vault toilets.

Install New Kiosks

The Grand Canyon-Parashant National Monument will purchase, and install new kiosks at locations throughout the Monument. The dimensions will vary from large four panel to smaller wayside panel kiosks. We will also be installing roofs on two of the existing four panel kiosks on the Monument (see picture above). Interns from the Intergovernmental Internship Cooperative program at Southern Utah University will assist with installation by stabilizing and rehabilitating soils. Estimated cost: \$15,000.

Connecting with Communities

The Bureau of Land Management and the National Park Service cooperatively conserve and protect undeveloped, wild, and remote northwestern Arizona landscapes and their resources within the Grand Canyon-Parashant National Monument. We coordinate and work with various Tribes, agencies, groups, and universities in providing opportunities for solitude, primitive recreation, scientific research, and historical and traditional uses within the monument. Examples of who we coordinate with include off-highway vehicle clubs, Arizona Game and Fish Department, Arizona State Historic Preservation Office, Kaibab Band of Southern Paiute Indians, Southern Utah University, and private property owners within the monument including the Bar 10 Ranch.
