Amount Expended: \$6,640.00

Each year, volunteer site hosts return to give service at Riverview Campground, Hot Well Dunes Recreation Area, and the Klondyke Ranger Station. Fee program funds are used to provide needed resources to assist in site host duties. Even taking into account the expenses of the volunteer program, their service helps reduce the overall budget of managing recreation sites. The saved labor costs are then used for other needs like cleaning supplies, signage, and facility maintenance.

Amount Expended: \$4,155.00

The Brandenburg Ranger Home and Contact Station are large investments that were made to administer the Aravaipa Ecosystem Management Plan and properly manage the wilderness permit system for Aravaipa Canyon Wilderness. This site serves as an important gateway to the Aravaipa Canyon area. Improvements were made to the living quarters that house a full-time park ranger. The public vault toilet near the contact center also received routine servicing for continued visitor use and convenience.

Pay Lease Agreements on Recreation Facilities near Aravaipa Canyon Wilderness - \$25,000

Pump vault toilets and purchase supplies for fee sites like fee envelopes, trash bags, toilet paper, and cleaning supplies - \$10,000

Continue to order and replace signage leading to and at recreation sites - \$12,000

Old Safford-Morenci Trail maintenance project - \$5,000

Begin to plan for E-Commerce Solutions at fee sites and areas (i.e. Scan and Pay, Off-Grid Kiosk, Digital Passes)

Locate and restore illegal dumping sites and unauthorized vehicle routes - \$5,000
