#### Amount Expended: \$9,903.71

In Northeast California, the Pit River Campground and Day use area is Just steps away from the incredible Pit River. Opportunities for recreation include swimming, angling, picnicking, birding, kayaking, river rafting and camping. The eight campsites offer fire rings, tables, and BBQs with two wheelchair accessible restrooms. Collections from recreation use fees and interagency passes were used for routine maintenance, limb and tree removal, law enforcement, and overhead costs.
