Amount Expended: \$2,391.20

Paying for your campsite at Bishop BLM Field Office campgrounds is now as simple as scanning a QR code with your phone. Campers can opt to pay camping fees at each site by downloading the free, easy-to-use www.Recreation.gov mobile app and using the 'Scan and Pay' option. The five campgrounds utilizing 'Scan and Pay' are Pleasant Valley Pit, Tuttle Creek, Goodale Creek, Crowley Lake and Horton Creek. Campground fees range from \$5-10 per night. The campgrounds are first-come, first-serve, with no reservations.
