BLM Employees conduct multiple Outreach Events throughout the high peak season for the El Centro Field Office which focuses on providing excellent customer service, providing information to the public while tying in recreation activities, or even interpretive talks along our popular areas within El Centro Field Office. Outreach events gives us the opportunity to reach and engage with the public through different activities, and to connect with our local communities and diverse group of visitors.

### Medical & Rescue Services

Amount Expended: \$430,705.68

The BLM El Centro Field Office provides an off-highway vehicle (OHV) emergency medical and rescue services in the Imperial Sand Dunes and across the Field Office. During the 2023-2024 use season, OHV Park Rangers responded to 253 calls, including 49 search and rescues. These park rangers are trained to search for and evacuate injured or lost riders and may use special OHV rescue capabilities such as vehicle extrication to complete the mission.

- Restroom maintenance: The ECFO has a total of 83 vault toilets. Most of these vault toilets are serviced and repaired daily.

- Conducted 39 outreach events which led to the passing of information to the public about all the different opportunities available.
