

# Campground Maintenance



Mattole Beach Campground & Mattole River

Amount Expended: \$40,905.00

Thousands of overnight visitors to the King Range NCA enjoy four front country campgrounds including: Wailaki, Nadelos, Tolkan and Mattole. The campground locations provide easy access to recreational opportunities along coastal beaches, day hike locations, and trailheads to backcountry wilderness areas. Campground fee revenue pays for contractors to remove trash and clean bathrooms (8 vault toilets). King Range NCA staff provide general maintenance in the campgrounds.

#### Maintenance of Day Use Areas

Amount Expended: \$35,880.00

Day use areas such as Mal Coombs Park, Abalone Point, Seal Rock, Mattole Beach and Black Sands Beach provide opportunities for recreational activities like tide pooling, beachcombing, whale watching, birding, and picnicking. Revenue collected from recreation fees is utilized to maintain the day use areas by removing trash, cleaning bathrooms (4 full-service bathrooms), mowing grass and providing landscaping services.

### Other Accomplishments

- In 2023, the King Range Business Plan was approved on October 26, 2023, by the Northern California Resource Advisory Council.
- The Mattole Campground Expansion Project was completed, providing 8 additional campsites and 20 parking spots for day use.
- King Range Trail Steward volunteers cleared and maintained 15 miles of trails over winter months to ensure safety.

The approved King Range NCA 2024 Business Plan will increase campground fees to \$15 per night and will implement a new \$12 per person fee for King Range Wilderness Individual Special Recreation Permits (ISRP). The King Range NCA will continue to provide maintenance for day use areas and will spend the new annual recreation fee revenue (projected: wilderness ISRPs=\$135,984; campground fees=\$40,020) on the following: \$66,106 Two seasonal Park Rangers, \$51,000 Annual trail maintenance, \$18,048 Support for local fire & rescue departments
