Campgrounds are an ongoing maintenance challenge but having functional campgrounds provide an invaluable experience for our campers. It is wonderful to see people enjoying the opportunity to recreate in our campgrounds away from the hustle of the city. Our water system at the S. Yuba campground has had several persistent issues that have arisen due to the age of the system. There are water permit requirements to maintain along with tacking and repairing elusive leaks along the distribution system.
