Amount Expended: \$22,094.96

To enhance recreational experiences, we have vault toilets at our most popular recreational destinations including the Trona Pinnacles National Natural Landmark, Desert Tortoise Research Natural Area, Spangler Hills, Jawbone Canyon, and Dove Springs Off-Highway Vehicle Recreation Areas. Funding was used to clean and maintain these facilities on a weekly basis as well as daily during busy holiday visitation. We also managed and maintained the Fossil Falls Campground and Day Use area.

UTV race conducted under Special Recreation Permit

Purchase and installation of OHV Trail Crossing signs along the Randsburg Wash Road within the Spangler Hills Off-Highway Vehicle Recreation Area - \$8,000.

Labor cost directly related to processing, administration, and monitoring of Special Recreation Permit request received by the Field Office - \$35,000.

Cost associated with the ongoing supplies, cleaning, pumping and maintenance of our 14 different vault toilet facilities throughout the field office - \$25,000.

Long range projects that will require carry over funding include:

Replacing signs at the Fossil Falls Campground - \$10.000.

Installation of two additional ADA accessible toilets in the Spangler Hills OHV Area - \$150,000.
