The FO will hire new staff to replace critical staff in both Field Operations and in SRP Administration. The FO is preparing to conduct a comprehensive SRP Audit and complete its move to the automatic and electronic RATOR system to provide enhanced service.

In 2024 the field office added a new boat operations building at the Pumphouse Recreation Area within the Special Recreation Management Area (SRMA) to enhance facilities, Funding from collected fees paid for this new structure.

Recreation staff and law enforcement will monitor SRPs) and make visitor contacts and outreach for OHV permittees, big game hunting and lion hunters.
