On August 19, the BLM in partnership with the Chesapeake Conservancy and Latino Outdoors facilitated a fossil hunting program at Douglas Point SRMA. This program was curated since fossil hunting is unique to the Eastern States Field Station. We led an interpretive hike down to the shore and then showed participants how to find fossils. The participants found a variety of fossils like shark teeth, ray crushing plates, and snail shells casting.
