Vertical 'Mulch' Along Route to Protect SS Plants

Amount Expended: \$1,577.68

For over 30 years, motorcycle groups have been coordinating with the Bruneau Field Office to sponsor racing events on BLM-managed land. There are typically two events each spring in a competitive use area in the northern portion of the field office. There is a disproportionate number of special status plants along many of the routes so BLM staff identify sensitive areas and install vertical 'mulch' (dead sagebrush) to protect populations. Staff also monitor impacts before and after the events.

Volunteers from Idaho Trails Association (ITA) have been actively helping BLM since wilderness designation in 2009. The six wilderness areas in Southwestern Idaho are collectively called the Owyhee Canyonlands Wilderness. Special recreation permit fees from outfitted & guided hunting in the wilderness areas are sometimes used to provide additional tools or supplies for these types of volunteer efforts.

The Bruneau FO is leveraging the Federal Lands Recreation Enhancement Act (FLREA) account in FY24 as matching funds for an Idaho Parks & Recreation grant application. If awarded, the grant will provide material for an outdoor classroom, and a road upgrade to the classroom, at the Perjue Canyon Hands on the Land site adjacent to the Little Jacks Creek Wilderness. Other partners providing matching funds include Sierra Club, Idaho Trails Association, and Idaho Conservation League. The minimal classroom infrastructure would include basalt column seating and a shade structure. The Field Office FLREA/1232 account receives about \$1,000-2,000 annually from 2-4 special recreation permits.
