Amount Expended: \$983.35

An ADA restroom and parking pad was replaced at the Jarbidge River Put-in 2023, through the Idaho Deferred Maintenance program. Funds charged to 1232 were for miscellaneous expenses of the Field Office Outdoor Recreation Planner to monitor construction at the site.

Pasadena Gravel Pit fence

Amount Expended: \$3,807.13

A popular parking spot and trailhead for mountain biking, hiking and recreational shooting in the Jarbidge Field Office (JFO), the Pasadena Gravel Pit also provides gravel for local highway department road maintenance in the JFO area. Fire staff assisted the Field Office Outdoor Recreation Planner in building a fence to separate some of the activities for public safety. Labor charged to 1232 was \$3,807.13.
