#### Amount Expended: \$0.00

Jump Creek features a surprising waterfall and lush riparian community filled with waterbirch and red osier dogwood trees. Visitors can hike the easy quarter mile Jump Creek Falls Trail, walk to the Falls Overlook or picnic near the rock crevices and meandering stream. Swimmers can enjoy a refreshing dip at the base of the falls. The Owyhee Field Office (OFO) is currently working on developing this area into a fee site. The Idaho Resource Advisory Council has given a positive recommendation for this change.

#### Amount Expended: \$3,783.94

Most of OFO's future 1232 funds will be spent on covering costs for a SWECO dozer for annual ATV/UTV trail maintenance within the travel management areas. Other 1232 funds will be spent on maintenance tools/items for the trails. These areas combined are roughly 260,000 acres and contain over 900 miles of designated routes. The areas require constant upkeep with sign repair and replacement, fencing repair, equipment rental, trail and cattle guard maintenance.
