Wilson Lake Campground Construction

Amount Expended: \$320,389.00

The BLM produced camping and reservoir day-use opportunities at Wilson Lake which is one mile north of Hazelton, Idaho. This project consisted of constructing an 8-site campground and 2 day-use sites. The total cost for the project was \$539,767. Of that \$320,389 was1232 funding. The 1232 funding was used to leverage a \$105k reimbursable grant from Idaho Department of Parks and Recreation Recreational Vehicle Fund.

Trail Construction



Silver lining trail construction

Amount Expended: \$24,500.00

In 2022 the BLM allocated \$133k to an Assistance Agreement with the International Mountain Bicycling Association to assist with constructing a total of 5.7 miles of single-track trail (Belle, Vue 2.0 & Silver lining trails) in the Wood River Valley immediately adjacent to Bellevue and Hailey, Idaho. The trails were constructed in 2023 by IMBA with the help from the BLM California Central Coast Field Office's specialized equipment and operator. The California support totaled \$24,500.

- Shoshone Field Office (SFO) funded Jarbidge and Burley Field Offices seasonal employees, \$45,000.
- SFO funded an agreement with the Blaine County Recreation District to assist with trail maintenance and education, \$14,000.
- SFO funded the Sawtooth Forest to assist with Bald Mountain Ski Area Permit administration and avalanche forecasting, \$25k.
- * Other revenue expenditures including labor, vehicles, supplies, and services totaled \$134,034.40.

Trail construction

The SFO will fund agreements with the International Mountain Bicycling Association and Wood River Trails Coalition to assist with constructing trails in FY 24 and preparing for construction in FY25 (\$33,000).

The SFO will also help maintain the Croy Creek motocross track (\$2,500), fund an agreement with the Blaine County Recreation District to assist with trail maintenance and outreach and education (\$15,000) and fund the Sawtooth Forest agreement to assist with Bald Mountain Ski Area Permit administration and avalanche forecasting (\$25,000).

Contribute \$26,870.83 to Idaho Strategic Recreation Fund.
