New zero-turn mower for the BLM Recreation Program

Amount Expended: \$3,006.42

The SDFO Recreation Program was able to purchase a new riding lawn mower with funds collected from fee sites and Special Recreation Permits. The mower replaced two previous tractor style mowers utilized in the campgrounds, parking areas and along the trails throughout the summer. The new zero-turn mower allows recreation staff to complete the mowing in about 1/3 of the time. The cost of the mower was shared with other resources in the South Dakota Field Office.

Fort Meade Recreation Area Maintenance

Amount Expended: \$3,162.78

At the Alkali Creek Campground and Horse Camp, funds were used for general maintenance of the area. Items such as fuel for mowers, water sampling fees, bathroom supplies, building repairs, cleaning supplies and garbage collection are just some of the purchases required to keep your public lands enjoyable and safe. It's important to show that while new amenities at campgrounds are great, much of the funds are utilized to keep what current assets we have maintained and clean for use.

Unfortunately, in Fiscal Year 24 the South Dakota Field Office will be using some of the funds collected to repair senseless acts of vandalism that occurred at the Fort Meade Recreation Area. In December, vandals destroyed four road closure gates, one kiosk, multiple sections of post and rail fence and a picnic shelter at the Alkali Creek Horse Camp. These repairs will cost \$15,000 just for the supplies with the work being completed by BLM staff and volunteer organizations. In May, vandals also damaged the vault toilet at Fort Meade Reservoir, which will require painting, repairing bullet holes, reinstalling toilet hardware, and window replacements.
