Amount Expended: \$1,500.00

The Black Rock Station is an important facility to the Black Rock Field Office and resides just outside the Black Rock Desert-High Rock Canyon Emigrants Trail National Conservation Area (NCA). There is a small visitor center where the public may obtain information on the many recreational activities available in the area. The station also serves as a forward operating facility for BLM recreation monitoring and wildfire response staff working in the NCA.

Amount Expended: \$10,000.00

The Black Rock Office spent significant time processing and monitoring multiple recurring Special Recreation Permits and reviewing several multijurisdictional SRPs. The majority of these are Outfitter and Guide permits but occasionally there is an offroad vehicle race or special event requiring an SRP. The field office staff ensures the recipients are adhering to the terms and stipulations of their permit, drafted to protect the natural and cultural resources in area.
