#### Amount Expended: \$20,751.89

BLM, along with support from state and local partners, continued implementation of the establishment for the North Reno Recreation Area (NRRA), establishing the area as a developed recreation site. This effort promotes Public Health & Safety and mitigates resource concerns. The resulting work in FY23 included the administrative site design, flood damage mitigation, increased Law Enforcement coverage for holiday weekends, and updates to site/regulatory signs, as well as a contract for restrooms.

# Campground Rebuild Continues

#### Amount Expended: \$0.00

In 2021 the Tamarack Fire burned through Indian Creek Campground. Wildfire impacts to site facilities, hazardous materials needing abatement, and risks associated with wildfire-affected "hazard" trees necessitated a campground closure. In 2022 significant flooding in the area contributed to site issues related to access and public health and safety. The campground will remain closed as staff works on public safety and infrastructure restoration.

- Provided law enforcement coverage at the North Reno Recreation Area and the Wilson Canyon OHV area.
- Worked with state engineering staff to complete a final design and implementation plan of the NRRA administrative site.
- Maintained roads throughout the NRRA and prepared campsites and emergency fire lanes for busy holiday weekend traffic.
- Worked with local non-profits to complete riparian restoration and protection of a riverbank damaged by recreational use.

In FY24, plans are to continue developing infrastructure at North Reno Recreation Area including construction of an administration site, provide increased trash services, administer and monitoring up to 25 Special Recreation Permits not under cost recovery, and continue law enforcement patrols at Wilson Canyon recreation area. Emergency Stabilization and Rehabilitation funds will be used to repair infrastructure within Indian Creek Recreation Area including the campground and Curtz Lake Trailhead.
