The Outdoor Recreation Planner (ORP) and the District Seasonal Camp Host have invested significant time and resources into revitalizing 14 picnic tables at Tabor Creek. Their efforts involved meticulously removing old paint, sanding, and refinishing each table. Additionally, the ORP and Camp Host undertook repairs on sections of the vault restroom roof and refreshed its interior with a new coat of paint. These enhancements are poised to elevate the recreational experience for all visitors.

The Wells Field Office's top priorities for the remainder of FY24 and into FY 25 are:

1. Refurbish and repair Tabor Creek Campground. The site needs considerable road work, erosion control, cleaning, painting, and new signage.
2. The Wells Field Office plans to roll previous funding over into future years to establish more developed recreational sites, in Salmon Falls Creek SRMA, near Jackpot, NV. Currently, there are no facilities for the public. WFO would like to add fire rings/pits and conduct trail work to improve access.
