Hood Mesa Parking Lot - Site of Planned Pavilion

In fiscal year 2024 we intend to purchase several shade structures for Recreation Site development. One area that we plan to install a new pavilion is at Hood Mesa Parking Lot.

Next year, Farmington Field Office also plans to improve wildlife waters. We will complete general maintenance and, in some cases, installation of solar pumps to provide consistent water in drought-stricken areas. This use is consistent with spending requirements as a significant portion of the funds received by the Farmington Field Office are related to commercial outfitting and guided hunts.
