During Fiscal Year 2023, Roswell Field Office personnel constructed a parking area near the Alleged UFO Skip Site. The purpose is to provide recreation opportunities as well as to emphasize the public values and allow for interpretation of cultural resources. UFO bus tours from Roswell are a definite possibility and would be authorized by a commercial Special Recreation Permit through the BLM Roswell Field Office. A hiking trail and trailhead gate with kiosk will soon be developed as well.
