The Owyhee WSR is known for its beauty and unique geology. 22 commercial outfitters offer guided trips for the public and 7 schools offer educational programs to their students. Unguided boaters also enjoy the river. BLM river rangers patrol the river educating users on river ethics, removing debris from the river, and generally providing a presence on the river. Recreation fees collected from outfitters support this effort through the purchase of needed equipment, and per-diem for patrols.

Amount Expended: \$4,856.00

The Owyhee River below the Owyhee Dam has grown into a world-class fly-fishing destination. Seven commercial guide companies operate on the river. Unguided anglers also fish in the river. There are no developed campsites or bathroom facilities. The BLM provides portable toilets, and trash service to protect resources. These services are funded with recreation fee dollars collected from the seven commercial outfitters and benefit all visitors recreating in the area.
