Post Fire Debris Removal and Recovery

Amount Expended: \$75,236.00

The Roseburg District has continued to focus the majority of recreation staff and resources on restoration of fire impacted sites in the Rock Creek and North Umpqua River corridor. Fee dollars have contributed to supporting staff time in ongoing debris removal, landscape restoration, utilities repairs, boardwalk and trail repair, and hazard tree cleanup. Work has been accomplished through contracts and partnership work with Oregon Youth Conservation Corps and Northwest Youth Corps.



Day Use Site and Trailhead Repair

Amount Expended: \$41,767.00

Fee dollars play an integral part in leveraging community support for our recreation sites. Multiple maintenance and restoration projects were accomplished by volunteers, with fee dollars funding the materials, supplies, and agency staff time to stage and facilitate the project work. Activities included multiple Eagle Scout Projects to restore day use areas and trailhead locations, trail and boardwalk restoration work through the Motley Crew, Source One Serenity, and Trail Keepers of Oregon.
