

Guides Assist with Treating Graffiti

Amount Expended: \$40,000.00

The Moab Field Office (MFO) coordinated 23 volunteer group projects with various partners including Red Rock 4 Wheelers, other permitted organized groups and guides, and Grand County. Projects included hiking and mountain bike trail maintenance and construction, invasive weed removal, 4x4 route work, staining recreation infrastructure, building fences, trash clean-up, and treating graffiti. These projects offer opportunities to share stewardship goals, protect resources, and enhance visitor experience.

Amount Expended: \$20,000.00

The MFO installed two new day use shade shelters, expanded parking, and installed Wild and Scenic Rivers signs along the Green River. The Mineral Bottom area includes a boat ramp for access to the Labyrinth Canyon (Wild and Scenic River) and Stillwater (Canyonlands National Park) sections of the Green River and an exit point for the Mineral BASE Jump Focus Area.

- * Toilet pumping and dumpster contract \$105,000
- * Manage numerous SRPs, including two new trail running events (Running Up For Air and the John Wayne Cancer Foundation Grit Series) - \$100,000
- * Partner with Grand County through Assistance Agreements for Sand Flats Recreation Area - \$40,000
- * Partner with Canyonlands Natural History Association for Moab Information Center Support -\$30,000
- * Implement the Moab Canyons Special Wildlife Area - \$4,000
- * Coordinate and host an inter-agency guide and outfitter workshop - \$8,000
