

Recreation Site Maintenance



Pine Creek Special Recreation Management Area 2023 funds were spent on supplies and labor to maintain six developed recreation sites. Restrooms and dumpster trailers received servicing throughout the season. The drinking water system at Fontenelle Creek Campground was tested monthly May through September and winterized at the end of the season and other maintenance tasks were performed to ensure visitor satisfaction and safety.

Kemmerer lost their Outdoor Recreation Planner in June of FY23 and were not able to secure a seasonal Technician which led to limited spending in FY23 on recreation maintenance.
