Expansion A

Starting from the south, the **western** boundary of expansion A (between existing Colville River SA and existing Teshekpuk Lake SA), is the southern/western boundaries of the following PLSS townships:

U001N005W, U001N006W, U002N006W, U003N007W, U003N008W, U004N009W, U005N009W, U005N010W, U006N010W, U007N010W, U008N010W

Starting from the western, the **northern** boundary of expansion A (between the existing Teshekpuk Lake SA and the existing Colville River SA) is the eastern/northern boundaries of the following PLSS sections*:

U008N001W31, U008N001W32, U008N001W33, U008N001W34, U008N001W35, U008N001W36, U008N001W25, U008N001E30, U008N001E29, U008N001E21

**same as southern boundary of expansion B*

Expansion B

Starting from the west, the **southern** boundary of expansion B (between existing Teshekpuk Lake SA & existing Colville River SA), is the southern/eastern boundaries of the following PLSS sections*:

U008N001W31, U008N001W32, U008N001W33, U008N001W34, U008N001W35, U008N001W36, U008N001W25, U008N001E30, U008N001E29, U008N001E21

**same as northern boundary of expansion A*

Starting from the west, the **northeastern** boundary of expansion B (between existing Teshekpuk Lake SA & existing Colville River SA), is the eastern/northern boundaries of the following PLSS sections:

U010N001E23, U010N001E25, U010N002E31

Expansion C

Starting from the west, the **southern** boundary of expansion C is the southern boundary of the following PLSS townships:

U003N016W, U003N015W, U003N014W, U003N013W, U003N012W

Expansion D

Starting from the west, where the boundary of expansion D meets the NPR-A boundary, the boundary of the western-most part of expansion D is the northern/western boundaries of the following PLSS townships:

U002N041W, U003N040W, U004N040W, U005N039W, U006N038W, U007N038W, U008N037W, U008N036W, U008N035W, U008N034W

Moving east, the next part of the expansion is made up of the following four townships (excluding native allotments):

U009N032W, U009N031W, U009N030W, U009N029W

Moving east and south, the next part of the expansion is made up of the following four townships:

U007N025W, U006N024W, U005N024W, U005N023W

Moving south, the next part of the expansion is made up of the following three townships:

U003N023W, U002N023W, U001N023W

Finally the southernmost part of expansion D (overlapping Colville River Special Area) is composed of the following four townships:

U004S025W, U005S026W, U005S027W, U006S027W
