Burro Creek Water System Repair



Scouts Finish Concrete Footers at Wild Cow

Amount Expended: \$1,222.59

In FY24, the Kingman Field Office (KFO) partnered with a local Eagle Scout applicant to complete new construction of a 12-foot-long pedestrian bridge located at the Wild Cow Springs Campground. The Eagle Scout installed footers, decking and handrails, and sealed the bridge decking and handrails. Completion of the project facilitated greater access to three campsites.



Excavator Backfills Waterline at Burro Creek

Amount Expended: \$7,234.76

In FY24, the Kingman Field Office (KFO) repaired a failed water valve at the Burro Creek Campground leading to the lower restroom. Funds were expended to upgrade the water supply line, valve, rent heavy equipment, and pay staff to complete the repair. The old potable water well at Burro Creek was also abandoned in FY24 to be compliant with Arizona Department of Water Resources regulations. This work is key to maintaining a safe drinking water system at the site.

Watchable Wildlife Panels in Need of Renovation

- Fund a campground host at the Burro Creek Campground - \$4,500.
- Fund a janitorial contract for the Burro Creek Campground - \$10,000.
- Fund a grader rental to repair site roads in Burro Creek Campground - \$24,000.
- Fund a groundwater study for the Burro Creek Campground Well -\$45,000.
- Fund operations and maintenance of three fee sites - \$22,146.
- Fund upgrade of watchable wildlife panels at Burro Creek - \$5,200.
