Amount Expended: \$844.00

In Northeastern Nevada, the Boulder Reservoir Campground and Day use area provides multiple opportunities for recreation including OHV use, swimming, angling, picnicking, birding, kayaking, and camping. The six campsites offer fire rings, BBQs, one wheelchair accessible restroom, and six new wheelchair accessible tables. Collections from recreation use fees and interagency passes were used for routine maintenance, campsite features, law enforcement and overhead cost.
