

Trailhead Janitorial Services



Badger Hills Trailhead

Amount Expended: \$26,000

During FY 2024, the BLM used about \$26,000 in funds received from Special Recreation Use Permits to continue with a daily janitorial services contract for the Badger Hills Trailhead and the Creekside Terrace Trailhead. Each trailhead served about 250,000 annual visitors in FY 2024.

Interpretation and Education

Amount Expended: \$2,500

During FY 2024, the BLM performed approximately 450 education and outreach classroom programs and guided hikes to enrich the community's understanding and appreciation of Monument natural resources. The BLM also completed the design of an interpretive panel for a Fort Ord parade horse (Comanche) that is buried on the Monument.

In FY 2025, the BLM plans to continue with janitorial services at the Monument trailheads. This contract will use about \$27,000 of recreation permit use fee revenue. In June of 2025, the U.S. Army turns 250 years old, and the BLM will provide several activities that honor the men and women of the United States armed services. The BLM will unveil the Comanche (Army Parade Horse) gravesite interpretive display and will refurbish the 11th Cavalry troughs nearby at this interpretive site.
