

Remote Off-grid Kiosks (ROKs) Volunteer Campground Hosts



Recreation User Pays Fees on a New ROK

Amount Expended: \$75,000.00

The Butte Field Office purchased and installed Remote Off-Grid Kiosks at eight different developed recreation sites in an effort to improve safety, efficiency, and sustainability of fee collection operations. The ROK, developed by SaniStar, allows visitors to pay recreation site use fees on site using credit or debit cards. The goal is to eliminate the need for traditional fee collection methods such as iron rangers and fee envelopes. Since the installation, recreation site users have given positive feedback.



Sid and Irene, National Volunteer Award Winners

Amount Expended: \$45,000.00

The Butte Field Office recruited 19 volunteers for the FY 24 season, who played a crucial role in maintaining the recreation sites and campgrounds. Volunteers assisted staff by checking in visitors, cleaning vault toilets, and answering public inquires. All of our volunteers always go above and beyond, but we had the honor of two of our campground hosts, Sid and Irene Noyes, being selected as Outstanding Volunteer Achievement Award winners in the BLM's 2024 Community Engagement Awards. Sid and Irene have volunteered at Spokane Bay boat-in campsite for 15 years.

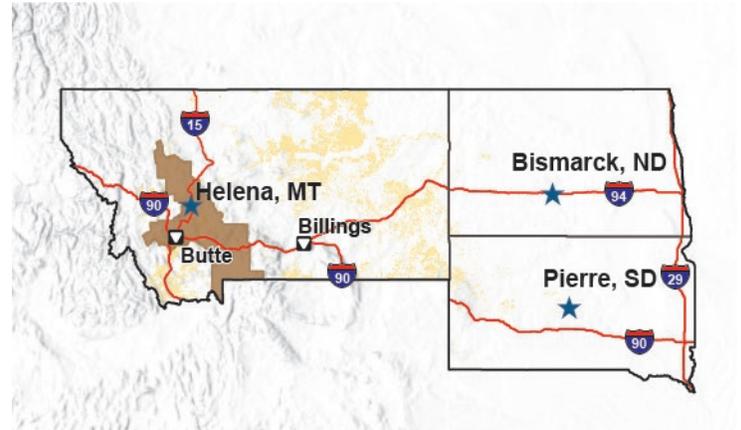

Other Accomplishments

- Scratch Gravel Hills trailhead improvements, including new gravel lots, trailer parking, fencing, and kiosks were funded through GAOA
- New well at Devil’s Elbow campground, \$100,000 from 1232 funds and \$98,000 from River Fund grant partnership with Northwest energy
- New solar arrays were installed at Devil’s Elbow, White Sandy, Holter Lake, and Log Gulch developed recreation sites. Installation of these solar arrays will offset the energy cost of operating these sites.
