Cottonwood Flood Damage

Amount Expended: \$6,500.00

The Milk River flooded in spring of 2023 causing significant damage to the Cottonwood Riparian Recreation Area. One quarter mile of fence was destroyed and most of the gravel was washed away. The fence was rebuilt in 2023 and new gravel was purchased, delivered, and smoothed in fall of 2024.


