Volunteers for Signature Day's Reenactment

Amount Expended: \$2,200.00

Pompeys Pillar is host to a number of special events throughout the year, from hosting school groups, interpretative programs and reenactments, such as Signature Day. Held annually on July 25th, this date commemorates Clark's visit to Pompeys Pillar. Mike Lamphier presented on the types of weapons the expedition members would have used and demonstrated the use of a black-powder rifle. Jacob Shropshire and Sam Hufford recreated a frontier camp, wearing traditional buckskin garments and cooking food over a fire.



National Public Lands Day Volunteers

Amount Expended: \$40,000.00

Career and seasonal Park Ranger staff, coordinate volunteer work days at Pompeys Pillar twice during the year. National Public Lands Day Held on September 28th, this trail cleanup encompassed all of our heavily-traveled trails adjacent to the Pillar. 4 volunteers cleared branches, rocks and other debris from the trails. This also helped clear obstacles and make the trails safer for athletes competing in the cross-country meet that was held two weeks later. Each year \$40,000 is spent on seasonal labor.


