Amount Expended: \$943.00

The BLM in coordination with local user groups have installed biking/hiking rollovers along the trails at the Fort Meade Recreation Area. This allows bikers and hikers to continue on the trails without having to open and close gates. There are approximately 15 of these along various non- motorized trails. There are also gates installed next to the rollovers that allow people on horse back to use the trails.



New flagpole at the BLM Alkali Creek Campground

Amount Expended: \$2,027.00

During a recent windstorm in South Dakota the flagpole at the Alkali Creek Campground was damaged beyond repair. A new, larger flagpole was purchased and installed using funds collected at the fee site. Many positive comments have been received from the public as it allows for a much larger flag, that is more visible from the service road.


