Cross Bar Trails Days Trail Ride

The Oklahoma Field Office and our partner, Friends of Cross Bar Special Recreation Management Area (SMRA), hosts quarterly "Open Trails Days." These events provide access to the property and the trails. Ordinarily, access to the Cross Bar is limited to hiking in from the Canadian River. Open Trails Days provide access through the administrative access route through private lands, while the Oklahoma Field Office and its partners work towards creating a public access road.

The Panhandle Trail Riders hosted a benefit ride for Friends of Cross Bar. This event attracted 29 equestrians who rode every trail and camped overnight.
