Water Quality at Santa Cruz Lake



BLM Field Staff Conducts Water Quality Testing

Amount Expended: \$3248.72

Taos Field Office has been conducting weekly water quality testing in Santa Cruz Lake for Cyanobacteria, a potentially toxic blue green algae. The bacteria are present in the lake, initiating the need for weekly testing during the summer months when warmer temperatures increase the likelihood of the algae. Five years of testing have shown that the bacteria has not become toxic to date and that Santa Cruz Lake is safe for recreation. Santa Cruz lake is visited by 35,000 people annually, primarily for water-based recreation activities such as fishing and paddle boarding.

Chama River Volunteer



BLM Ranger Hauls Refrigerator Out of Chama River

Amount Expended: \$2460.00

Taos Field Office (TFO) employed a full-time volunteer at El Vado Ranch, the put-in for the Wilderness section of the Wild and Scenic Rio Chama, co-managed by BLM and the US Forest Service. The volunteer conducted familiarization/safety briefings, equipment checks, and checked-in multi-day river users. This allowed the river patrol rangers a greater presence on the river and facilitated increased patrols on other Wild and Scenic Rivers managed out of the TFO. The volunteer also ran weekly vehicle shuttles for River Rangers on Rio Chama patrols, preventing the need for a second ranger.

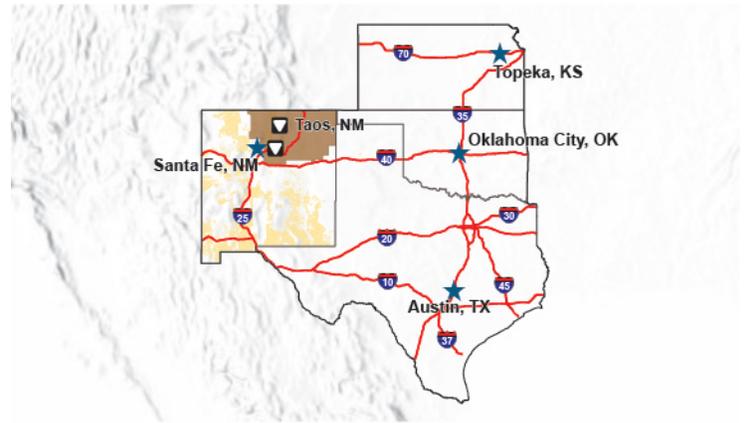
