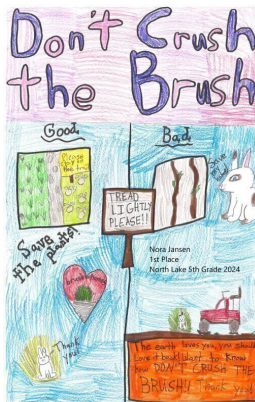

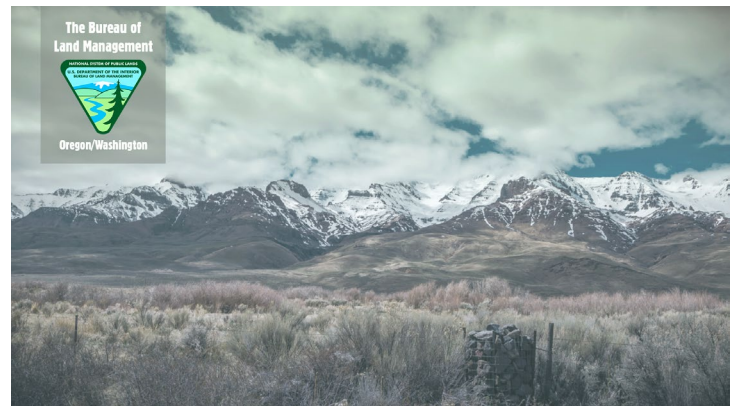
Recreation Fee Program Spending & Accomplishment Highlights 2024

- Data collection began on a comprehensive sign plan. New signs will be designed, purchased, and installed where needed.

- Buck Creek Watchable Wildlife Site improvements, includes a trail system with signs and interpretive kiosks, an ADA-accessible parking area and viewing areas, and road improvements. This project serves the North Lake County community.
- Dark Sky Sanctuary EST 3/11/24. Future reaction opportunities could include designated viewing areas, site development, brochures, maps, mobile apps, viewing parties, SRPS, etc..
- Hart Bar Interpretive Site redesign and ADA improvements.
