The bridge now provides connectivity between the new Roundabout and Scenic Byway trails. Volunteers from both Iron Trailcraft and Boy Scouts of America Troop 74 assisted in the construction.

BLM staff collaborated with the Zion National Park Roads Department to stripe roads and crosswalks at the popular Parowan Gap Petroglyph Site, as well as paint ADA symbols in paved parking stalls at the petroglyph site, the "C" Overlook, and the Three Peaks Recreation Area remote control car track.

Conceptual design of the Southview Trailhead

The Cedar City Field Office plans to make improvements to the Southview Trailhead, which is a primary access point for the BLM-managed Iron Hills National Recreation Trail System. The improvements will include expanding the parking area to accommodate up to 65 vehicles, paving the parking lot, and adding shade structures and picnic tables. Estimated cost: \$125,000.
