Campsite with Bear Resistant Food Storage Box

Amount Expended: \$2,000.00

Pinedale Field Office installed 8 bear-resistant food storage boxes at Scab Creek Campground. This better aligns BLM management practices with the adjacent Bridger-Teton NF Food Storage Regulations. These regulations requires all users on surrounding USFS lands to store their food inaccessible to bears. Installation of these bear boxes will help to improve public safety and protect wildlife by reducing the opportunities of food habituation.



Cooperative Weed Spraying

Amount Expended: \$3,000.00

Pinedale Field Office provided funding to the Sublette County Weed and Pest District for weed spraying. The funding that was provided specifically focused on addressing noxious and invasive plants at recreation sites within the Green and New Fork Rivers Special Recreation Management Area, an area heavily used by our Special Recreation Permit holders and public boaters. By treating invasive species along these high use areas, this agreement will help limit the spread of these species within the area and county.

Other Accomplishments

- Supported a Campground Host program at Warren Bridge Campground; a fee CG with 17 sites, water, and a dump station. Volunteers are available for support, education, security, maintenance, and a positive BLM presence.
- Hosted a volunteer group of local high schoolers at a BLM CG. Students had the opportunity to learn about careers in recreation and completed routine CG maintenance such as painting picnic tables and cleaning fire pits.
- Maintenance and care of boat launches in conjunction with WY Game and Fish. Pinedale has 20 boat launches which are used by public and permit holders and are designed to protect natural resources.
