Amount Expended: \$113,000.00

A comprehensive trail inventory began in the Black Rock National Conservation Area (NCA), ensuring responsible recreation management while preserving the area's unique natural and cultural resources. This agreement enabled collaboration between the Bureau of Land Management (BLM), partner organizations, and local volunteers, enhancing public access and environmental stewardship.

Amount Expended: \$7,500.00

Volunteers and BLM staff installed and repaired more than 200 feet of fencing near Trego Hot Spring. The new fencing closed off areas prone to habitat disturbance, preventing unauthorized vehicle access and reducing potential harm to kit fox dens. Additionally, repairing damaged sections helped maintain protective barriers around ecologically sensitive zones and cultural heritage sites, ensuring long-term preservation.
