

Instructions for Land Acquisition Project Data Sheets
Department of the Interior

Project/Unit:	Text	Enter in the official name of the Federal unit or project.
State(s):	Drop-Down	Select the State that the land activity is located in. You can add/remove States by clicking on the Add and Remove buttons. Up to 14 States can be added.
Priority:	Number	Enter the rank of the project as it appears on the bureau's final integrated project list. WO will complete this prior to sending to DOI
Discretionary/ Mandatory:	Check-Box	Select the type of funding. Field should leave this Blank. WO will fill this in for projects that are selected for funding.
Congressional District(s):	Text	Enter in the congressional districts; with the state abbreviation - district number. Separate more than one entry with commas "," (ex: AZ-1, AZ-2, NM-1). Refer to www.govtrack.us/congress/membership for state abbreviations.
Location:	Text	Briefly describe the location of the project. Include county / counties when known.
Select Categories:	Check-Box	<p><i>This is a hidden field and is only visible on the screen.</i></p> <p>Select all categories that pertain to this project.</p> <ul style="list-style-type: none"> • Access (select this if the acquisition will enable new public access to a previously restricted public resource) • Cultural/Historic (select this if the acquisition will protect resources of formally recognized historic or cultural value, including paleontological, archaeological, prehistoric or historic resources) • Fire (select this if the acquisition will help in the prevention or reduction of future fire threat, or will enable the agency to better manage for desired fire objectives and/or to use fire as a management tool) • Hunting/Fishing (select this if either hunting OR fishing will be allowed on all or part of the property acquired, subject to regulations) • Recreation (select this if the public will be permitted to access the acquired property to enjoy recreational activity of any kind: motorized, non-motorized, concessioner-guided or non-guided, etc.) • Species of Concern (select this if the acquisition includes designated critical habitat, is part of a habitat conservation plan, or otherwise contributes to the conservation of listed species, candidate species, surrogate species, or other identified species of concern) • Water (select this if the acquisition will provide significant benefit – which includes protecting the status quo, in the case of imminent threat – for water quality, quantity, municipal water supply or aquatic habitat benefit) • Working Lands (select this if the acquisition will support the traditional uses on working land, e.g. forestry, ranching, farming)
